STIPULATION AND ~~PROPOSED~~ ORDER

Plaintiff Amgen Inc. (“Amgen”) and Defendants Hoffmann-La Roche Ltd, Roche Diagnostics GmbH and Hoffmann-La Roche Inc. (collectively “Roche”), by and through their undersigned counsel, hereby jointly stipulate to entry of final judgment and a permanent injunction against Roche based on the following stipulation:

1. The following claims of the Amgen EPO Patents are valid, enforceable and are infringed by the manufacture, importation, use, offer to sell or sale of Roche’s Peg-EPO product in the United States:

- (i) U.S. Patent No. 5,756,349 claim 7,
- (ii) U.S. Patent No. 5,547,933 claims 3, 7-8,
- (iii) U.S. Patent No. 5,955,422 claim 1,
- (iv) U.S. Patent No. 5,441,868 claims 1 and 2, and
- (v) U.S. Patent No. 5,618,698 claims 6-9.

2. Roche withdraws and agrees to a dismissal with prejudice of its claims, defenses and counterclaims raised in this matter.

3. Amgen and Roche jointly stipulate to entry of judgment and a permanent injunction, as set forth in the proposed order below.


